The number of members necessary to consider a quorum being present, the Mayor called the meeting to order and announced the meeting was in session for the transaction of business. Jonathon Benson presented a check to the City for \$35,161.80 from Missouri Public Utilities Commission C/O Missouri Rural Water Association from a 2020 interest bearing rebate for a loan for Water & Waste Water improvements.

Barry Gilmore proposed to the City the dumping of the water from the trash that is usually

taken to Union City by Waste Pro to be directed to the Waste Water Treatment Plant. There would testing every 60 to 90 days for any containments at Waste Pro's expense. Waste Pro would pay the City a fee by the gallon for the dumping; generating income for the City. Chief Tony Jones reported that he had placed on Facebook about checking for city stickers, and giving people a couple of weeks to pay their taxes or get fined. Most people personal property taxes are little to none, but some elude from paying their City taxes. Chief Jones stated that something would have to be done about the lighting at the American Legion, especially with the incident that occurred over the weekend. Chief Jones urged the City to make contact with the person over the American Legion to avert liability.

Training for the month of July, "Scene Safety", taught by Randy Guest. Fire inspections were conducted at the Caruthersville School District on Monday July 25, 2022.

Code Enforcement; Barry Gilmore reported that he was waiting on the proof for the signage for the cemetery which would be more legible. Councilperson Lyons motion to go with what the Cemetery Committee had recommended, second by Councilperson Rittenberry with all in favor. Barry Gilmore made mention that the old substation on 3rd St. would be torn down eventually; a new substation, new power lines, and poles will be put up. The City will go ahead and take on the expense, and will be reimbursed by Ameren. Mr. Gilmore also reported that mowing had been ongoing, he obtained a quote to clean out the gas tanks; the mosquito sprayer and the 25 cents on the water bill for the mosquito

spraying was still on the table. After some discussion, Councilperson Lyons motion to have the 25 cents taken off the water bill by abating the tax for the next two years. Councilperson Grable second the motion, which resulted in the following vote:

Library report; Marsha Hayes reported that Thursday August 11, 2022 there will be an Active Shooter Seminar from 8:00 a.m.-11:00 a.m. The Mission Impact Kids from the Agape Center will be performing August 6, 7, and 13, 2022.

Collector report; Paige Gillock had been really busy today, with people coming to pay their taxes to get their stickers. Collections from July 1, 2022 through July 31, 2022 are as follows: Real Estate \$6,968.80, Personal Property \$295.07, Drainage Districts \$550.00, Miscellaneous \$478.00, Total Taxes \$6,156.94, Interest and Fees \$2,134.93, Total Collections \$8,291.87. The Total Collections just for today were \$5,410.51.

New Business; Councilperson Grable reported that a Ribbon Cutting Ceremony would be tomorrow at 10:00 a.m. for G&C, the new diner on Truman. Mayor Grantham received acceptance of another grant for the airport improvements through MODOT for \$296,328.00 which is underway with Waters Engineering being the consultant; the City will pay \$15,000 for their match. Mayor Grantham also announced that the City had received the additional \$218,487.25 from FEMA for reimbursement for the flood repairs.

Business From the Floor; Barry Gilmore made mention that the manhole on 7th & Ward would be done this week. A representative from C & S Cleaning Supply stated that they do a lot of business in the area, and they're looking forward to serving the community needs, and might in some instances be able to save money for their services.
