The number of members necessary to consider a quorum being present, the Mayor called the meeting to order and announced the meeting was in session for the transaction of business.

The first order of business was a motion by Councilperson Harmon to go into closed session, seconded by Councilperson Cartee which resulted in the following vote:

Upon returning from the closed session, the Mayor left the room, and Mayor Pro Temp Harmon conducted the meeting. Harmon states that the insurance bid would be awarded and the Chairman of the Insurance Committee, Cheek presented a letter from Attorney Jim DeReign. The letter stated that the bid from Bernard Insurance was lower due to Ellington's earthquake and flood insurance not being included in their bid. The Chairman's recommendation was to accept Bernard's bid and stay with MOPERM. There was discussion following the recommendation. Councilperson Cartee asked Terry McVey his opinion of the bids, he concurred with DeReign stating that Bernard's bid was lower. MOPERM is inclusive with its earthquake and flood insurance, which is the most striking difference. There is a coinsurance with SAVERS in Ellington's bid, whereas

Mark Gibbins, representing Ellington proposed to share the business, and asked to be the agent of record.
