The number of members necessary to consider a quorum being present, the Mayor called the meeting to order and announced the meeting was in session for the transaction of business.

The purpose of the meeting was to discuss the budget for the upcoming year. Councilperson Bullington lead off the meeting by presenting a budget for the Council to review. The recommendation was to adopt the current budget same as last year with amendments being instituted at a later date. Bullington basically imported the current employees and their salaries and information gathered from department heads. McDowell and Middleton provided documentation of actual hours worked by every employee and what their final salary would be.

Overview of the budget, started off with the General Fund, projected and proposed revenues and expenditures. The Finance Committee would like to meet with the department heads to discuss the budget to clarify some of the ways that revenues can balance out expenditures. Once the final expenditures and revenues have been calculated it will change the projected and actual expenditures and revenues hopefully for the better.

Salaries and benefits are major expenditures which need to be controlled by sticking to the 80 hour, 2080 hours yearly proposed in budget. The Police based on 2223 hours yearly and Fire department 2756 hours.
